



SERVICE AGREEMENT

This Service Agreement ("Agreement"), dated February 11th, 2025, is between **Tony Mitri**, henceforth referred to as ("Author") and **Adept Ghostwriting**, a California limited liability company located at 11704 Wilshire Blvd, Los Angeles, CA 90025, USA (dba www.adeptghostwriting.com), henceforth referred to as ("Ghostwriter").
